ANATOMY OF FRENCH HORRIBLE CRIME BY OBSESSED GAME PLAYER STABBED LOUISE TO DEATH

VICTIM WAS ONLY 11 YEARS OLD

USPA NEWS - FraLouise was an 11-year-old schoolgirl, a diligent and determined student, gifted with her hands and always at the top of the class. She disappeared on February 7, 2025 after leaving school in Epinay-sur-Orge and was found stabbed to death in Templiers Woods. Her tragic death sparked strong emotion and incomprehension in the face of this unbearable crime. This abominable murder made the headlines of all the media in France for two decades, on TV and in the written press and online. Several international media reported highlight the global attention this tragic case has received, emphasizing its impact beyond France's borders. Our Agency is also publishing the tragic case, gathering a timeline (excerpts of the Republic Attorney) of the murder and the holistic view of the tragedy, as a bearing minimum homage to Louise the 11 years old girl who died so savagely. These tragic cases highlight the persistence of violence against minors in France, with on average 1 child dying every five days, killed by one of their parents. Our Bureau publishes this tragic affair, as much as we got committed so far to break these tragic news, not only to alert the public but to pay tribute to the victim

OWEN L. AGGRESSIVE MURDERER ALREADY REPORTED TO POLICE AFTER BEATING UP & S HIS OWN SISTER & STABBING LOUISE TO DEATH

Owen L., 23, is the alleged murderer of Louise, 11. Here is a summary of his profile:

- Born in 2001 in the 19th arrondissement of Paris, French national
- Lived in Epinay-sur-Orge, near his parents' home
- Former student at the middle school where Louise was educated
- Described as "nervous, violent, aggressive"
- Known to the police for having beaten his little sister on several occasions
- No known psychiatric disorder, but could be "disturbed" and "very violent"
- From a "well-integrated" family: father in the banking sector, mother in the cultural sector
- Confessed to Louise's murder after two nights in police custody
- Acted in anger after an argument over the game Fortnite
- Indicted for murder of a minor under 15 and placed in pre-trial detention (Source: Liberation, Parisien, Valeurs Actuelles,

Neighborhood investigation was crucial in identifying Owen L. as a suspect:

The suspect's younger sister recognized her brother on CCTV footage, including his dark down jacket and cap. Several witnesses identified Owen L. as the man following Louise on the videos. During a door-to-door canvass, investigators noticed his resemblance to the suspect and injuries on his hands, leading to his arrest.

TERRIBLE TIMELINE OF THE STABBING THAT KILLED LOUISE BY OWEN.L PRESUMED KILLER, EXPALINED BY PUBLIC PROSECUTOR OF EVRY

The chronology of the precise facts of the unfolding of events leading to the meeting of Louise and her future murderer, following her disappearance on February 7, revealed in an extremely precise manner by the Public Prosecutor of Evry, Gregoire Dulin, Here is a chronological summary of Louise's drama over the last 7 days, based on the statements of the Essonne prosecutor and the available information. Here is the chronology of the events that led to the meeting of Louise and her near-murderer who had the misfortune to meet him, then murdered by many people stabbed to death.

February 7, 2025

- Louise, 11, disappears after leaving André-Maurois middle school in Epinay-sur-Orge around 3 p.m.
- Her parents report her disappearance to the police around 3:30 p.m.

- A search is launched, involving the police and residents.

February 8, 2025

- Around 2 a.m., Louise's body is found in the Templiers Woods
- An investigation for "murder of a minor under 15" is opened.
- The autopsy reveals numerous wounds caused by a sharp object.

February 10, 2025

- A security system is set up around the schools.
- Investigators continue their search for clues.

February 11, 2025

- Owen L., 23, is arrested and taken into custody.
- His parents and his partner are also taken into custody.

February 12, 2025

- Owen L. confesses to Louise's murder.
- The Essonne prosecutor holds a press conference.
- Owen L. is brought before the public prosecutor for murder of a minor under 15.
- His partner is brought before the public prosecutor for failure to report a crime.
- Provisional detention is requested for Owen L.

The prosecutor reveals that Owen L. killed Louise in a fit of anger after an argument over the game Fortnite. He left his house armed with an Opinel (Ordinary knife) and followed Louise before attacking her in the woods. (Source BFM TV)

TOO MANY OTHER TRAGIC & SIMILAR CASES IN FRANCE ARE REPEATING THEMSELVES FOR YEARS

1. ELIAS 16 YEARS OLD CASE STABBED TO DEATH (January 2025)

Elias, 14, was stabbed to death near a stadium in Paris. Two underage suspects aged 16 and 17 were arrested. One of them confessed to having stabbed him to death during an attempted cell phone theft.

2. CELYA 6 YEARS OLD CASE KDNAPPED & KILLED case (July 2024)

Celya, 6, was found dead in Saint-Martin-de-l'If (Seine-Maritime) after a kidnapping alert was triggered. The prosecutor reported "extremely violent events".

THE HORRIBLE LOLA CASE HIT FRANCE AS THE EFFECT OF A MEDIATIC EARTHQUAKE IN 2022

The Lola case concerns the murder of Lola Daviet, a 12-year-old girl, which occurred on October 14, 2022 in Paris. Here are the main elements of this tragic case:

1. DISAPPEARANCE AND DISCOVERY

- Lola disappeared after leaving Georges-Brassens middle school in the 19th arrondissement of Paris.
- Her body was found in a plastic trunk in the courtyard of her building around 11:30 p.m.

2. THE AUTOPSY REVEALD A HORRIBLE CRIME

- The autopsy revealed that Lola died of asphyxiation.
- The body had significant wounds to the throat and the numbers "0" and "1" written under her feet.
- The victim was allegedly subjected to acts of torture, barbarity and rape.

SEVERAL FOREIGN MEDIA HAVE REPORTED THE LATEST TRAGIC CASE LOUISE'S MURDER SPREADING A LARGE FEAR IN FRANCE

- Dahbia B. confessed to the murder before retracting.

4. LEGAL PROCEEDINGS AMID ACTS OF RAPE MURDER & BARBARITY

- The Paris prosecutor's office requested a trial at the assizes for "murder accompanied by rape, torture or acts of barbarity".
- A judicial investigation was opened for "murder of a minor under 15, in connection with a rape committed, with acts of torture and barbarity".

5. THIS MURDER SPREAD HUGE FEAR & NATIONAL SHOCK OVER THE SAVAGE MURDER OF LOLA IN FRANCE

- The case caused strong emotion in the neighborhood and on a national scale¹.
- A psychological unit was set up to support the people working on the case².

This tragic case continues to leave its mark, particularly due to its extreme violence and its apparently senseless nature (Source : Le Parisien, RTL, BFM TV, CNews TV)
